STOP OFF CHARGES:	\$ 100.00 First Stop
	\$ 150.00 Second Stop
	\$ 200.00 Third Stop
	\$ 300.00 Fourth Stop

* DETENTION OF VEHICLES WITH POWER-TRUCKLOADS	Two hours free time will be allowed. After 2 hours a charge of \$75.00 per hour will be assessed or \$18.75 per quarter hour thereafter.

DETENTION OF VEHICLES WITHOUT POWER	0 to 24 hours is free time. After 24 hours there is a \$75.00 per day or any fraction there of including weekends and holidays. In addition, a pick up charge of \$100.00 will be charged for picking up the trailer.

LUMPER CHARGES	If carrier's driver is to assist, count, tailgate, load and/or unload the charge will be \$150.00 for each service performed or the total price charged by the loading and/or unloading service whichever is higher . If assist, count, tailgate, load/unload is not completed within one hour for LTL or two hours for TL , detention with power charges will apply @ \$75.00 per hour or fraction thereof until completed.

EQUIPMENT ORDERED & NOT USED	When the carrier is requested to perform transportation service and dispatches transportation services and dispatches equipment to a point designated, in accordance with the instruction of the party ordering the equipment, and instructions to the carrier are later changed and the equipment is not used due to no failure of the carrier except Acts of God, a charge of \$1.25 per mile , from the point which dispatched via the shortest practical route, subject to a minimum charge of \$75.00 will be made for the empty miles travelled in connection with the equipment ordered and not used. Distance will be determined by use of the applicable PC Miler Mileage Guide. The party requesting the service(s) will be responsible for the charge named in this item.

COLLECT ON DELIVERY (COD) SHIPMENTS	(a) The COD charge applies only when the carrier picks-up a check for the customer's merchandise. (b) Carrier must be notified, at order acceptance, if load is going to be COD. (c) The charge for collecting and remitting the amount of each COD bill collected on shipments cosigned COD will be \$75.00

PICK UP OR DELIVERY SERVICE SATURDAYS, SUNDAYS, OR HOLIDAYS	When requested or required, Saturday, Sunday, or holiday pick-up or delivery service will be provided at an additional \$150.00 per vehicle.
